For nearly 20 years, South Texas Dermatopathology Laboratory has been privileged to include renowned dermatopathologist Dr. Thomas L. Davis as a valued member of its pathology staff. Dr. Davis is nationally board-certified in dermatology and in dermatopathology. Dr. Davis' medical education credentials are impressive, having earned a medical degree (M.D.) from the University of Texas School of Medicine, San Antonio, TX. Since then, Dr. Davis successfully completed: a one-year internship in internal medicine at the Wilford Hall Medical Center, Lackland Air Force Base, San Antonio, TX; a three-year residency in dermatology at the Wilford Hall Medical Center, and a one-year fellowship in dermatopathology at the New York University Langone Medical Center, New York City, NY. Prior to attending medical school, Dr. Davis earned a Bachelor of Science degree in biology from Baylor University, Waco, TX. In recognition of his academic achievements during his undergraduate years at Baylor, Dr. Davis was selected for Phi Beta Kappa Society membership—an honor bestowed on only an estimated one-percent of all college seniors, nationwide. An excellent teacher and speaker, Dr. Davis has served as a faculty member at several regional and national meetings.

Dr. Davis served in a series of key positions within both the academic and clinical service arenas, including ten years of honorable service as an active-duty US Air Force military officer, as exemplified by the following:

- Chief of Dermatology, 509th Strategic Hospital, Pease Air Force Base, Portsmouth, NH (1987-88).
- Chronologically: 1) Dermatologist, 2) Chief of Dermatopathology, 3) Assistant Chair, Departments of Dermatology/Pathology, Wilford Hall Medical Center, Lackland Air Force Base, San Antonio, TX (1989-93).
